#### **Purpose:**

Maintain outreach communication with all the providers enrolled in the Puerto Rico Medicaid Program (PRMP) through the official documents distributed in the PRMP web site, Learning Management System (LMS), Provider Contact Center and other communications through the Managed Care Organization (MCO), Medicare Advantage Organization (MAO), and Pharmacy Benefits Management (PBM).

### Scope

All references to the PRMP in this policy are inclusive of Children's Health Insurance Program (CHIP) and Puerto Rico Medicaid Program. This policy applies to all providers enrolling in PRMP.

#### **Policy**

PRMP is responsible for implementing laws passed by Congress and regulations related to the Medicaid Program and CHIP. To implement these programs, PRMP issues various forms of guidelines to explain how laws and regulations will be implemented and what providers need to do to comply.

Provider must use the PRMP official website, LMS, Provider Contact Center and MCO, MAO, and PBM communications to confirm policies, requirements, and other official documents or information.
