Re: PRMP Provider Enrollment - Wave 1 and Wave 2 Training and Enrollment Dates

This letter reinforces important information regarding the requirement to enroll in the Puerto Rico Medicaid Program (PRMP) via the Provider Enrollment Portal (PEP). All providers that provide, bill for, order, prescribe, or refer services for Medicaid beneficiaries under the Puerto Rico Government Health Plan (Vital or Platino Medicare plans) are required to enroll. Important information, including dates for training and enrollment, is provided below.

As a reminder, the PRMP will implement the PEP to comply with the Affordable Care Act of 2010 (ACA), which requires State Medicaid Agencies (SMA) to enroll providers in the Medicaid Program.

#### **Wave Schedule**

Providers will enroll in waves by their provider type, with the first wave starting in early April 2020 and the last wave starting late in the year. Only the provider types listed in each wave should enroll during their respective wave. Other provider types will be enrolled in subsequent waves and the schedule for those waves will be published soon.
