Re: Provider Enrollment Portal (PEP)— Wave 3 Training and Enrollment Dates

This letter reinforces important information regarding the requirement to enroll in the Puerto Rico Medicaid Program (PRMP) via the Provider Enrollment Portal (PEP). All providers that provide, bill for, order, prescribe, or refer services for Medicaid beneficiaries under the Puerto Rico Government Health Plan (Vital or Platino Medicare plans) are required to enroll. Important information, including dates for training and enrollment, is provided below.

As a reminder, the PRMP will implement the PEP to comply with the Affordable Care Act of 2010 (ACA), which requires State Medicaid Agencies (SMA) to enroll providers in the Medicaid Program.

## **Wave Schedule**

Providers will enroll in waves by their provider type. Provider Types listed in Wave 3 begin their enrollment from May 11, 2020 and will conclude in July 6, 2020. The provider must register in their corresponding phase.
