1.	What is the current version of Cúram that the Medicaid Information Technology Initiative Third Generation (MEDITI3G) system is running in production?	The current version of Cúram is 7.0.11.
2.	Was a Cúram upgrade ever performed after the system went live on June 1, 2021? If yes, how many and from which version to which version?	No Cúram upgrades have taken place since the system went live June 1, 2021. The system will upgrade to version 8 in 2024.
3.	How has the system acceptance been with the end users since MEDITI3G Go-Live?	Puerto Rico Medicaid Program (PRMP) and its current vendor continue to work toward user adoption and change management.  Continued emphasis on increasing automatic determinations and decreasing manual interventions remains a priority. Please refer to the answer to Question 4 for additional reflections on system adoption.
4.	What are the top three pain points of MEDITI3G expressed by end users?	Three areas that PRMP continues to focus on relative to MEDITI3G include:  1. Case processing time (the amount of clicks it takes to process a case)  2. Reporting capabilities and accuracy of data to develop reports  3. System not being user-friendly (number of manual interventions required)

10.	What is your budget for the planned modernization?	PRMP has not finalized a budget for this planned modernization effort. PRMP's budget may be influenced by the findings of this Request for Information (RFI), and if/when the RFP is released the budget will be based on the desired functions and features of the system as detailed in the RFP.
11.	Has the PRMP evaluated any alternative technologies or seen system demos as part of the planned modernization effort?	PRMP is interested in the vendor community's perspective on how PRMP should modernize its Eligibility and Enrollment (E&E) system and is open to feedback on the approach.
